Committee name: Committee on Ethnic Diversity in Linguistics (CEDL)

Committee charge: Recognizing that some ethnic and racial minorities in the United States are significantly underrepresented in the linguistics workforce and in the membership of the LSA, and that it is in the interest of the field of linguistics and of American society to be enriched by the participation of all its ethnic groups, the LSA established a Committee on Ethnic Diversity in Linguistics. Its principal charges are:

- 1. Helps the Society and the profession identify, publicize, and implement ways of improving the recruitment, retention, and professional development of linguists from underrepresented ethnic minorities.
- 2. Makes recommendations to the Society and the profession concerning ways in which full equality of opportunity can be provided to all who seek to study, teach, or conduct research in linguistics.

The Society acknowledges the wide range of ways in which the term 'ethnic minority' may be interpreted. The Committee's work is directed to those groups which are clearly underrepresented at all levels in the linguistics workforce relative to their numbers in the US population. Such groups include African Americans, Native Americans, Hispanic Americans, and Americans from a variety of Asian and Pacific Islander backgrounds. The activities of the Committee are not limited to any stipulated set of such groups but are aimed at increasing access to and diversity within the field on a broad basis.

Executive Summary: Following the recommendations of those in attendance at the January 2019 meeting, and using the bulleted list of responsibilities on the CEDL webpage as a guide, the Committee revised its internal structure to include the following five subcommittees: (1) Awards and Nominations (2) Demographics and Data Collection (3) Communications and Outreach (4) Events and (5) Networking and Mentoring. Each committee was then asked to identify 2-3 goals for their respective subcommittees, most of which were reflected in the mid-year report submitted in April. In the report that follows, the accomplishments during this reporting period, goals for the remainder of the reporting period, and goals for next year are provided for each subcommittee (with minor edits made by the CEDL chair in order to fit each report into the given template).

Action Items (including specific requests for endorsements or approvals by the Executive Committee at its forthcoming meeting)

The following action items are requested by CEDL for the 2020 calendar year:

 The CEDL chair requests that the CV database proposal (attached) be vetted by the Executive Committee either before or during the upcoming LSA meeting. If the proposal is approved, we request that CEDL be consulted in the implementation of the database and supporting infrastructure and that the LSA assist in making its members aware of the new resource, once it is available.

- The CEDL Networking and Mentoring subcommittee requests that the LSA provide resources to create the following listservs: (1) Latinx Linguistic and Language Scholars, (2) Indigenous Linguistic and Language Scholars, (3) Asian/Pacific Islander Linguistic and Language Scholars, (4) Black Linguistic and Language Scholars, and (5) Underrepresented Linguistic and Language Scholars of Color
- The CEDL Awards and Nominations subcommittee will once again request financial support for the CEDL Travel Grant Awards when the LSA's call for funding proposals is made.

Accomplishments during this reporting period:

• Nominated *Linguistics in Pursuit of Justice*, by John Baugh, for the Leonard Bloomfield Book Award. While Baugh's book was not ultimately selected this year, it was an honor to recognize and celebrate the important contributions that his work has made and will continue to make to our field.

Demographics and Data Collection

Accomplishments during this reporting period:

The activities of the Data subcommittee of the CEDL have been slow but not for lack of initiative. Following the presentation on harassment given at the 2019 LSA, the committee spent about two months brainstorming ideas on what sorts of data would prove useful for the LSA and academic administrators to have when considering the issues of equal opportunity. This led to a rather lengthy "wants" list of data to be gathered by the CEDL (including numbers reflecting People of Color (POC) in tenure-track faculty positions in linguistics and affiliated fields, POC in contingent positions, and numbers of POC declared undergrads and grads). These efforts were largely put on hold when presented to Alyson Reed, who informed us that the LSA, at the administrative level, would soon be engaged in similar data collecting measures. The Data subcommittee has been kept up to speed with all of the LSA's data collection plans and concerns/questions relayed to Alyson.

Also, pursuant to the goals of the Demographics and Data Collection subcommittee and at the recommendation of CEDL member John Rickford, CEDL chair Tracey Weldon submitted a proposal to Alyson Reed for the creation of an ethnic minority CV database to be housed on the CEDL webpage (see attachment). The gist of this proposal was vetted by the Demographics and Data Collection subcommittee, who expressed support for the idea. The proposed database is intended to assist in the hiring and promotion of underrepresented scholars in the field by providing greater visibility and access to their academic profiles. The proposed infrastructure could also be adopted by other LSA committees and special interest groups to support their respective missions and goals.

Goals for the remainder of the reporting period:

CEDL chair Tracey Weldon has requested that the CV database proposal be vetted by the Executive Committee either before or during the upcoming LSA meeting.

Goals for the next year:

We are hoping that the LSA's plans to conduct large-scale data collection on demographics (including those important to the CEDL) come to fruition this coming year. We are also hopeful that some version of the CV database proposal will be approved and implemented early next year.

Communications and Outreach

Accomplishments during this reporting period:

The Communications and Outreach Subcommittee had the following goals for 2019: (1) to produce and begin distribution of an informational document on avoiding bias in reference writing, with faculty recommendation writers as the intended audience and (2) to begin collecting information with the goal of producing an informational document on the importance of diversity in linguistics.

In accordance with these goals, the subcommittee contacted the LGBTQ+ SIG and COSWL to establish channels for cooperative work, inquire about interest in collaboration, and determine if the groups had their own existing work related to our stated goals that they would be willing to share. In addition, the subcommittee began work on the content of the informational document and prepared communication for distribution through social media and email, requesting brief testimonials on how the field of linguistics benefits from diversity. Unfortunately, a lack of participation from the full subcommittee stymied our efforts to complete these goals.

Pursuant to the subcommittee's goals, however, CEDL chair Tracey Weldon collaborated with LGBTQ+ SIG and COSWL members Tyler Kibbey, Rusty Barrett, and Melissa Baese-Berk to organize a panel, entitled <u>Toward an Intersectional Linguistics</u>, which was accepted for the upcoming LSA meeting and will include presentations by CEDL members deandre miles-hercules and Jessica Grieser, as well as Ariana Steele, Elaine Chun, and co-organizers Tyler Kibbey and Rusty Barrett.
